PHILIPPINE SCOUTING CENTENNIAL JAMBOREE

In line with the commemoration of the *100 Years of the Introduction of the Scouting Program in the Philippines*, the Boy Scouts of the Philippines (BSP) will hold its *Philippine Scouting Centennial Jamboree* with the theme *Peace and Development Through Scouting* by cluster on the following dates and venues:

Cluster	Date	Venue
Luzon	November 4-8, 2014	Goodyear SimeDarby, C.M. Recto Street Barangay Fortune, Marikina City
Visayas	November 7-11, 2014	Capitol Hills Scout Camp, Cebu City
Mindanao	November 9-13, 2014	Zamboanga Freeport Zone Barangay Talisayan, Zamboanga City

At the end of the Jamboree, the participants should be able to:

1. recognize the historical significance, cultural heritage and development of the Scouting movement in the Philippines, and its contribution to the character development of the young people and their role in nation-building;
2. undertake community service projects related to environment, peace and development through the *Messengers of Peace Initiatives*, *Scouts of the World Award* and *World Scout Environment Programmes*;
3. participate in the Global Development Village and City of Science, and learn global issues on environment, human rights, health, education and science and technology;
4. develop core life skills and the 21st century leadership capabilities through team-building, cooperative learning, group dynamics, creative problem-solving and decision-making; and
5. celebrate the 100 Years of the Introduction of the Scouting Program in the Philippines with greater emphasis on brotherhood, friendship and camaraderie.

The target participants must be: (1) registered Boy Scouts (10-12 years old); (2) at least Grade 5 with Second Class Scout Rank; (3) Senior Scouts (13-17 years old); (4) at least 2nd Year High School with Pathfinder Scout Rank; (5) physically fit as certified by a duly licensed physician; and (6) equipped with personal camping gears.

This activity shall be subject to the *no-disruption-of-classes policy* stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.
