RESOLUTION NO. 9034

WHEREAS, on May 7, 2010 the Commission En Banc promulgated Resolution No. 8878, which resolved to activate the registration records of members of the BEI with deactivated registration records in connection with the May 10, 2010 National and Local Elections;

WHEREAS, for purposes of the October 25, 2010 Synchronized Barangay and Sangguniang Kabataan Elections and future elections, there is a need to reinstate above-cited policy in order to address possible shortage of public school teachers by reason of inadvertent deactivation so that they shall continue to serve in the elections;

NOW, THEREFORE, the Commission on Elections, by virtue of the power vested in it by the Constitution, the Omnibus Election Code, and other election laws, has RESOLVED, as it hereby RESOLVES to allow the public school teachers with deactivated registration records to serve as Board of Election Tellers (BETs) for the October 25, 2010 Barangay and SK Elections pending verification of the inadvertent deletion of their names from the lists of voters.

The Education and Information Department (EID) shall cause the immediate publication of this Resolution and shall furnish copies thereof to the Department of Education, all Regional Election Directors, Provincial Election Supervisors, Election Officers and Boards of Election Inspectors nationwide.

RESOLUTION No. 9038

WHEREAS, Section 3 of Executive Order No. 94 dated March 2, 1987 provides as follows:

> Sec. 3. Prohibition on Barangay officials - No barangay official shall be appointed as member of the Board of Election Inspectors or as watcher of each duly registered major political party or any socio-civic, religious, professional or any similar organization of which they may be members.

NOW THEREFORE, to ensure that the October 25, 2010 Barangay and Sangguniang Kabataan elections is peaceful, orderly, regular and credible, the Commission on Elections, by virtue of the powers vested in it by the Constitution, the Omnibus Election Code, Executive Order No. 94, and other election laws, RESOLVED, as it hereby RESOLVES, to PROHIBIT:

- 1. The appointment of barangay officials such as the Punong Barangay, Kagawad, Secretary, Treasurer, and Tanod, in the October 25, 2010 Barangay and Sangguniang Kabataan elections as:
 - a. Chairman and/or Member of the Board of Election Tellers or Barangay Board of Canvassers; or
 - b. Official watcher of any candidate, or any socio-civic, religious, professional organization, or accredited citizens' arms.

This Resolution shall take effect on the seventh (7th) day after its publication in two (2) daily newspapers of general circulation in the Philippines.

The Education and Information Department shall cause the publication of this Resolution and furnish copies hereof to the Secretary of the Department of Interior and Local Government, the Secretary of the Department of Justice, the Department of Education, the Regional Election Directors, the Provincial Election Supervisors and the city/municipal Election Officers, and give this Resolution the widest dissemination.
