CREATING THE DEPED ALTERNATIVE DISPUTE RESOLUTION TECHNICAL WORKING GROUP (ADR-TWG)

- 1. In consonance with DepED Order No. 22, s. 2007, entitled, "Compliance with Executive Order No. 523, which Instituted the Use of Alternative Dispute Resolution in the Executive Department of the Government," and DepEd Memorandum No. 100, s. 2010, entitled, "Establishment of an Alternative Dispute Resolution (ADR) System in the Department of Education (DepEd)", a Technical Working Group (TWG) is hereby created to craft and prepare the ADR policy framework that will be installed and implemented in the DepEd.
- 2. The ADR-TWG shall have the following tasks:
 - a. Prepare the policy framework and its implementing guidelines for the ADR system that will be most suitable and applicable in the DepEd;
 - b. Review the implementing guidelines of the ADR system in other government offices; and
 - c. Consolidate comments and suggestions gathered from the participants in the ADR training-workshops and consider the same in the preparation of the policy framework.
- 3. The ADR-TWG shall have thirty (30) days from its initial meeting to complete the preparation of the DepEd ADR policy framework and its implementing guidelines.
