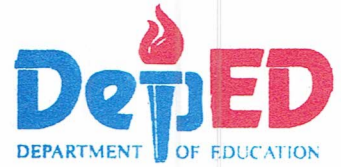


**MONITORING OF THE 2017 BRIGADA ESKWELA IMPLEMENTATION**
