REGIONAL TRAINING OF TRAINERS FOR THE DEVELOPMENTALLY-APPROPRIATE PRACTICES (DAP) IN THE EARLY LANGUAGE, LITERACY AND NUMERACY TRAINING PROGRAM (ELLNP)

TO: Schools Division Superintendents

- 1. In consonance with DepEd Memorandum No. 222, s. 2016 (Developmentally-Appropriate Practices (DAP) in the Early Language, Literacy And Numeracy Training Program (ELLNP) the Regional Office through the Curriculum and Learning Management Division will hold the Regional Training of Trainers for the Developmentally-Appropriate Practices (DAP) in the Early Language, Literacy And Numeracy Training Program (ELLNP) on May 2-8, 2017 at a venue to be announced later.
- 2. The activity aims to:
 - a. enhance knowledge and skills in early language, literacy and numeracy;
 - b. gain understanding of child development principles vis-à-vis developmentally appropriate practices;
 - enhance knowledge on the different classroom-based assessments as tools for documenting and reporting the learner's progress; and
 - d. foster sustained commitment for working towards improved instruction and learning outcomes.
- 3. Expected participants are the RO-CLMD Education Program Supervisors and Curriculum Implementation Division (CID) Education Program Supervisors in-charge of Mother Tongue, English, Filipino, Mathematics, Kindergarten and Multigrade. In case of EPS's taking charge of two areas (e.g. English and Mother Tongue), an ELLN trainer may be included to complete a team of six (6) participants from every division. - 4. Participants may check-in at the venue in the afternoon of Day 0 (May 1). First meal to be served is dinner of Day 0 while last meal is afternoon snacks of Day 7 May 8). The training matrix is found in enclosure 1.
