



<p>1. There is an increasing number of research outputs from 2015-2018 from 32 to 215 completed studies under Basic Education Research Fund. However, only 11% of the total outputs were utilized by the schools, SDO and ROP. Based on the monitoring report from the completers, teacher-researchers were hesitant to apply their findings in teaching because they might be questioned by their immediate superior. Aside from that, they were not supported in school as to utilization of their research findings.</p> <p>2. Based on the consultative meetings with Research managers, Research Management Guidelines, DO No. 16, 2017, do not contain specific guidelines on how these researches will be utilized as well as monitoring of utilization.</p>	<p>To ensure that the utilization rate will increase, the Region may focus not only on quantity but more on quality through establishing regional research framework aligned to Regional directions and programs.</p> <p>It is recommended that the Regional Research Development and Innovation Committee (RRIDC) through PPRD may come up with guidelines and monitoring tools on utilization of research from 2019-2020.</p>	<p>For 2019, PPRD shall facilitate the regional research framework and manage research initiatives aligned with the strategic directions of the Region in specific and DepEd in general. Example of this is the Specialized Projects on Research and Resource Kits (SPARKS) which will be implemented from 2019-2022. Moreover, a local policy shall be drafted on research utilization.</p>
