THE FIRST MANDATORY CONTINUING LEGAL EDUCATION SEMINAR FOR DEPARTMENT OF EDUCATION ATTORNEYS

To: Undersecretaries **Assistant Secretaries** Bureau and Service Directors **Regional Directors** Minister, Basic, Higher and Technical Education, BARMM Schools Division Superintendents All Others Concerned

- The Department of Education (DepEd), through the Office of the Assistant Secretary for Legal Affairs (OASLA), will conduct The First Mandatory Continuing Legal Education (MCLE) Seminar for DepEd Attorneys as part of its efforts to capacitate the lawyers to more efficiently and more effectively handle legal concerns brought to their respective offices. The Institute for the Administration of Justice of the University of the Philippines Law Center will serve as facilitators. This will be held from November 19 to 22, 2019 within Metro Manila. The venue will be announced in an Advisory.
- 2. The 1st MCLE seminar aims to
 - a. discuss legal matters concerning the constitutional right to basic education in light of recent developments in law and jurisprudence;
 - b. assist the lawyers in complying with the MCLE requirement set out in Supreme Court Bar Matter No. 80; and
 - c. improve the overall discharge of the legal functions of the Department.
- This will be primarily participated in by attorneys of the Legal Affairs Strand in the central, regional and schools division offices of DepEd. Invitation will also be extended to other lawyers in other strands/offices in the central office and different field offices in the regions and schools divisions. The list of offices with the corresponding number of participants is provided in Enclosure No. 1.
- Confirmation of participants must be done not later than November 8, 2019 5. through email at asec.legal@deped.gov.ph using the Confirmation Slip provided in Enclosure No. 2. They are advised to make sure that all information indicated in the slip are correct and final. she
- 6. Other pertinent details of the activity are as follows:
 - a. Check-in is at 2:00 p.m. on November 18, 2019 (Day 0), while checkout is at 12:00 noon on November 23, 2018 (Day 5). Accommodation beyond this period will not be covered by the Office.
 - b. Food will be served starting with dinner on Day 0, while the last meal is lunch on Day 5.

- c. All participants are encouraged to be in the venue as early as Day 0 to maximize the credit units of the seminar. Physical presence and prompt attendance are required for the granting of credit units.

- 8. Travel and other incidental expenses of all participants from the field offices in the regions and schools divisions shall be charged to local funds, while those of the central office participants are chargeable to the funds of their respective strands. All expenses shall be subject to the usual accounting and auditing rules and regulations.
