CONTRACT FOR SMALL VALUE PROCUREMENT OF CATERING SERVICE

2024 JUN 0 this CONTRACT made and entered into day THIS 2024 by and between the DEPARTMENT OF EDUCATION, located at DepEd Complex, Meralco Avenue, Pasig City, represented herein by its Undersecretary and Chief of Staff Head of Procuring Entity, ATTY. MICHAEL WESLEY T. POA, as per Office Order OO-OSEC-2023-267 (hereinafter referred to "DEPED"); and ACEREIL VALERIO BASCO (AICEE CATERING FOOD SERVICES), represented herein by its Owner, ACEREIL V. BASCO with office address at Blk 5 Lot 6 Corvette St., Thunderbird Subd., 174 District 1 Caloocan City, Brgy. 174, (hereinafter referred to as the "AICEE CATERING FOOD SERVICES").

DEPED and AICEE CATERING FOOD SERVICES are collectively called

DEPARTIES.

PARTIES. WHEREAS, DEPED requested quotations from prospective service providers for the procurement of catering service for Procurement of Meals for the Conduct of the 126th Philippine Independence day Celebration (National Flag Day Celebration) - During Preparation, and received quotation from two (2) prospective service providers; **DEPED** evaluated the offer of the prospective service providers and declared AICEE CATERING FOOD SERVICES as having the Lowest Calculated Quotation for the project; after post-qualification, DEPED declared the quotation of AICEE CATERING FOOD SERVICES as the Lowest Calculated Quotation in the sum of PHILIPPINE PESOS: FIFTY FOUR THOUSAND PESOS 00/100 (\$\mathbf{P}\$54,000.00) only, (hereinafter called the "Contract Price") detailed as follows:

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

- In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Project Reference.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 shall be deemed to form and be read and construed as part of this Contract, viz:
 - Resolution to Award No. 2024-EASU-051(CS) dated May 28, 2024;
 - Notice of Award of Contract and AICEE CATERING FOOD SERVICES's conforme thereto;
 - c. AICEE CATERING FOOD SERVICES's offer, including the eligibility requirements, technical and financial proposals, and all other documents or statements submitted;
 - d. Technical Specifications (Annex "A"); and
 - e. Other contract documents required by existing laws and/or **DEPED**. **AICEE CATERING FOOD SERVICES** agrees that additional contract documents of information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution such as, but not limited to, Notice to Proceed and Variation Order, shall form part of the Contract.
- The lease of catering service referred to in this Contract shall commence on June 10, 2024 and end on June 11, 2024, subject to AICEE CATERING FOOD SERVICES's receipt of the Notice to Proceed (NTP).
- 4. The lease of catering service referred to in this Contract must conform to and comply with the final technical specifications as approved by the Procurement Committee of the Events Assistance and Services Unit based on the actual offer of AICEE CATERING FOOD SERVICES, and reflected in the post-qualification report, which is hereto attached as Annex "B" and made an integral part hereof.

Any proposal by **AICEE CATERING FOOD SERVICES** to provide goods, services, and/or equipment of different specifications, in lieu of those approved, shall not be allowed. However, under justifiable circumstances, higher or superior technical specifications may be permitted, subject to the evaluation and favorable recommendation of **DEPED**'s end-user or implementing unit, and the approval of the herein authorized signatory. In any such case, the proposal by **AICEE CATERING FOOD SERVICES** for substitution shall not result in any additional cost or undue burden to **DEPED**.

- **AICEE CATERING FOOD SERVICES** shall be responsible for the sources of its goods, services, and/or equipment, and shall provide the same in accordance with the schedule and specifications of the award, including incidental and additional services as specified in the Project Reference, if any. Failure on the part of **AICEE CATERING FOOD SERVICES** to comply with this provision shall be a ground for cancellation of the Contract.
- One-time/full payment of the Contract Price shall be made to **AICEE CATERING FOOD SERVICES** within 60 days, through the Government disbursement procedure and subject to applicable taxes, upon DEPED's receipt of the complete documentary requirements from **AICEE CATERING FOOD SERVICES**. Such payment shall be based on the actual number of

registered participants, or the minimum guaranteed number of participants as indicated in the Schedule of Requirements.

Other documents in support of a request for payment may be required by **DEPED** pursuant to existing disbursement, accounting, and auditing rules and procedures.

- AICEE CATERING FOOD SERVICES shall be liable for liquidated damages in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion, for every day of delay. DEPED shall deduct the liquidated damages from any money due or which may become due to DEPED. Once the accumulated amount of the liquidated damages reaches 10% of the Contract Price, DEPED may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.
- The PARTIES shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the PARTIES in connection with the implementation of the Contract. Should such dispute not be resolved amicably, it shall be submitted to Early Neutral Evaluation pursuant to Republic Act No. 9285 or the "Alternative Dispute Resolution Act of 2004", and its Implementing Rules and Regulations.
