16th MITSUBISHI ASIAN CHILDREN'S ENIKKI FESTA 2024–2025

The National Coordinating Body of Clubs for United Nations Educational, Scientific and Cultural Organization (UNESCO) in the Philippines Inc. (NCBCUP) will conduct the start of the 16th Mitsubishi Asian Children's Enikki Festa 2024–2025 in the Philippines from July 1 to October 31, 2024.

The Enikki Festa is designed to provide an opportunity for children worldwide to understand and appreciate Asian people's daily lives through illustrated diaries with the theme, My life that I want to share with anyone in Asia.

The Mitsubishi Public Affairs Committee, Asian Pacific Federation of UNESCO Clubs and Associations, and National Federation of UNESCO Associations in Japan are organizing this event with the goal of promoting literacy so that all people in the world can read and write. This is in line with UNESCO's initiative to further encourage cultural understanding and respect among children in Asia.
