This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders. It shall form an integral part of the bidding documents issued earlier relative to the above project.

I. Section I. Invitation to Bid

1. Item No. 2, page 8, is hereby amended to be read as follows:

Original Provision bidder Prospective should have completed, within a period of ten (10) years immediately preceding deadline for submission of bids, Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority's (PSA's) Consumer Price Index (CPI), must be at least fifty percent (50%) of the ABC.

Provision as Amended

Prospective bidder should have completed, within a period of ten (10) years immediately preceding deadline for submission of bids, a Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority's (PSA's) Consumer Price Index (CPI), must be at least fifty percent (50%) of the ABC of the lot bid for; OR at least two (2) similar contracts and the total of the aggregated contract amount should equivalent to at least fifty percent (50%) of the ABC of the lot bid for; and the largest of these contracts must equivalent to at least twenty-five

percent (25%) of the ABC of the lot to be bid for.

2. Item No. 7, on page 9 of the bidding documents stated, as follows:

Bids must be duly received by the BAC Secretariat at or before 10:00 a.m. (Philippine Standard Time) of May 13, 2024 at Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City. Bids will be opened, immediately after the aforementioned deadline for receipt of bids, in the presence of the bidders' representatives who choose to attend the activity.

Late bids shall not be accepted.

Only **two (2) representatives** per bidder will be allowed to enter inside the venue.

For the purpose of constituting a quorum, both the physical and virtual presence of the BAC members shall be considered pursuant to GPPB Resolution No. 09-2020.

A statement either in the Bidder's statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the applicable laws and issuances.]

All other provisions not herein modified shall remain in full force and effect.
