## Provision as Supplemented/Amended

## Minimum Qualifications of the Contractor

1. The CONTRACTOR must be competent and experienced in the field of waterproofing works with a minimum of five (5) years prior experience on 3 similar projects and should have a valid and current Philippine Contractors Accreditation Board (PCAB) License, Category "C" or "D", with a classification General Engineering (GE-1) or Specialty – Waterproofing Work (SP-WP).

2. The CONTRACTOR is required to submit a company profile, list of present and previous clientele for the past five (5) years, and certifications issued by past/present clients indicating the

Contractor's satisfactory performance.

3. Contractor shall have a Single Largest Contract with similar project contract and scope such as waterproofing works. Within five (5) years from the deadline of bid submission, who's the value of contract amount must at least fifty percent (50%) of the ABC with supported by the Contractors Performance Evaluation
