Late bids shall not be accepted.

- 9. Bid opening shall be on **December 15, 2023, <u>9:00 A.M.</u> at Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 4. Section II. Instruction to Bidders, page 13, Item 15, page 17, is hereby amended to be read as follows:

"Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification. <u>Any</u> <u>discrepancy between the hard/paper copies and the copies</u>

contained and as presented in the USB Flash Drive the former shall prevail."

5. Section III. Bid Data Sheet, ITB Clause 20.1, Submission of Sample, page 27, is hereby amended as follows:

"Submission of Samples:

In addition to the documentary requirements to be submitted during post-qualification as provided under ITB Clause 20.1, the bidder(s) with the Lowest Calculated Bid(s) for Lots 2,3,4,5,9,10,11,12,13 & 19 shall submit <u>ONE</u> sample item/unit for all the items within the lot(s) bid for, consistent with their actual offer as indicated in their bid. However, the bidder may provide a sample of better or superior quality, which, of accepted, shall be the reference for award, contract, prospection and eventual delivery.

These samples shall be subjected to evaluation during postqualification to determine compliance of the said bidder/s with DepEd Technical Specifications requirements.

Replacement of Samples. Bidders whose samples failed the technical specifications shall be given three (3) calendar days upon receipt of the notice from the BAC to replace their failed samples. Replacement of samples may be allowed only once. The failure of the replacement sample to comply with the technical specifications shall be a ground for disqualification. Submission of samples will be at the Department of Education Central Office.

Failure of the samples to meet DepEd specifications shall be a ground for disqualification of the bidder/s.

Please refer to **Annex "D"** for the **Inspection and Test Protocol** of the Mass Production items and Market Items. In case the item will be manufactured from abroad, the bidder may submit its list of equipment and a video showing the manufacturer's plant and equipment from abroad to prove the bidder's capability to manufacture the item.

- Supplier's name and contact details

Packaging should be according to the allocation list per school.
