This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders and shall form an integral part of the bidding documents issued earlier for the above project.

**1. Section I. Invitation to Bid, Item 7, page 9, is hereby amended to be read as follows:**

“Bids must be duly received by the BAC Secretariat on or before **8:30 A.M. of August 31, 2023** at Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City.

**Late bids shall not be accepted.”**

**2. Section I. Invitation to Bid, Item 9, page 9, is hereby amended to be read as follows:**

“Bid opening shall be on **August 31, 2023, 9:00 A.M.** at Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Ave., Pasig City. Bids will be opened in the presence of the bidders’ representative who choose to attend the activity.”
