



Is the release of Science, Mathematics Equipment and various LR's simultaneous with the Notice to Proceed, given that the contract becomes effective forty-five calendar days after receipt of the Notice to Proceed?	Yes, the stage covering implementation of procurement contracts starts with the issuance of the Notice to Proceed (NTP) to the supplier.
Do you also have an established hauling plan for both projects that we will follow/use within the given delivery timeframe?	The supplier shall be the one to establish the hauling plan.
What specific details are required in the third column labeled "Bidder's Actual Offer"?	The "Bidder's Actual Offer" should be at least what is indicated in the Scope of Services/Terms of Reference and must be marked as "Complied".
	The prospective bidder can copy the exact statement provided in the Scope of Services/Terms of Reference and must indicate compliance. However, the prospective bidder may alter the declaration of preference if it can provide a significantly better service as long as the minimum requirements are met.
For loading and un-loading, will our counting be based on per mother box count?	Counting will be based per copy of the LRs.
Is it safe to assume that the fragile items are securely packed prior to pick-up?	Yes. The items are securely packed prior to hauling.
Any additional packaging requirements needed from the hauler? Kindly specify.	None.
List of vehicles to be used/Plate Numbers/Name of Driver/Helper, will you also require submission of hard copy of OR/CR of all the trucks	All submitted or declared documents during the Bid Opening shall be validated during the Post-Qualification, which requires the presentation of the original and hard copy.

Under letter D, is the contract performance certified by the end user supported by all three attachments or just one of them? If all three attachments are required for the end user's acceptance, can we also include the Certificate of Completion?	
Can we submit BIR Form 2303 instead of the DTI Certificate?"	BIR 2303 is different from DTI Certificate and should be both submitted if applicable.
