This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders and shall form an integral part of the bidding documents issued earlier for the above project.

- 1. Section I. Invitation to Bid, Item 2, page 7, and Section II. Instructions to Bidders, ITB Clause 5.3, page 12, are hereby amended to be read as follows:**

“Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder should have a Single Largest Completed Contract (SLCC) at least one (1) contract similar to the project to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority’s (PSA’s) consumer price index (CPI), must be at least fifty percent (50%) of the ABC of the lot bid for; **OR at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least fifty percent (50%) of the ABC of the bid for and the largest of these similar contracts must be equivalent to at least twenty-five percent (25%) of the ABC of the lot to be bid**”
