



Yes, the stage covering implementation of procurement contracts starts with the issuance of the Notice to Proceed (NTP) to the supplier.
Do you also have an established hauling plan for both projects that we will follow/use within the given delivery timeframe?	Hauling Plan shall be both established by DepEd and the winning bidder prior to the issuance of the Notice to Proceed.
What specific details are required in the third column labeled "Bidder's Actual Offer"?	The "Bidder's Actual Offer" should be at least what is indicated in the Technical Specifications/Terms of Reference and must be marked as "Complied".
	The prospective bidder can copy the exact statement provided in the Technical Specifications/Terms of Reference and must indicate compliance. However, the prospective bidder may alter the declaration of preference if it can provide a significantly better service as long as the minimum requirements are met.
For loading and un-loading, will our counting be based on per mother box count?	The winning bidder shall be given a delivery document that specifies the number of boxes to be hauled and delivered.
