This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders and shall form an integral part of the bidding documents issued earlier for the above project.

1. Section I, Request for Expression of Interest, Item 2, page 6, is hereby amended to be read as follows:

"The DepEd, through the Bids and Awards Committee (BAC) V, now calls for the submission of eligibility documents for **Procurement of ISO 9001: 2015 Third Party Audit and Certifying Body for DepEd Regional Offices**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before 1:00 P.M. of October 10, 2023 at Rizal- Alonzo Garden Area (RAGA) Conference Room, DepEd Complex, Meralco Ave., Pasig City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

Late bids shall not be accepted.

Opening of eligibility documents shall be at 2:00 P.M. of October 10, 2023 at Rizal- Alonzo Garden Area (RAGA) Conference Room, DepEd Complex, Meralco Ave., Pasig City. Eligibility documents will be opened in the presence of the bidders' representatives who choose to attend."

2. Section I, Request for Expression of Interest, Item 5, page 7, is hereby amended to be read as follows:

"The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its 2016 Revised Implementing Rules and Regulations (IRR). The short list shall consist of three (3) to seven (7) consultants, with five (5) as the preferable number, who will be entitled to submit bids.
