CONTRACT

DEPED and **SOONEST GLOBAL** are collectively called **PARTIES**.

WHEREAS, DEPED invited bids for the Procurement of Freight, Handling, and Forwarding Services for the Delivery of procured TVL Tools and Equipment utilizing the FY 2022 Funds stored at Nikka Trading's Warehouses consisting of one (1) Lot, and received bid from four (4) prospective bidders; DEPED opened, read, and evaluated the bids of the bidders and declared SOONEST GLOBAL as having the Lowest Calculated Bid; after evaluation, DEPED post-qualified and declared the bid of SOONEST GLOBAL as the Lowest Calculated Responsive Bid in the sum of PHILIPPINE PESOS FIVE MILLION, SIX HUNDRED EIGHTY-EIGHT THOUSAND, THREE HUNDRED FORTY-FIVE AND 60/100 (PhP5,688,345.60) ONLY, (hereinafter called the "Contract Price") detailed as follows:

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

- 1. In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Contract, viz:
 - a. Resolution to Award No. 2024c-BLR4(007)-BII-CB-026 dated May 22, 2024;

- SOONEST GLOBAL's bid, including the eligibility requirements, c. technical and financial proposals, and all other documents or statements submitted;
- Performance Security; d.
- Notice of Award (NOA) of Contract and SOONEST GLOBAL's e. conforme thereto; and
- Other contract documents required by existing laws and/or DepEd f. in the Bidding Documents. SOONEST GLOBAL agrees that additional contract documents of information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution such as, but not limited to, Notice to Proceed and Variation Order, shall form part of the Contract.
- **SOONEST GLOBAL** shall post a Performance Security within 10 calendar 3. days from receipt of the NOA in the form and amount prescribed therein. The Performance Security shall be posted in favor of **DEPED**, and shall be forfeited in the event that it is established that SOONEST GLOBAL is in default of any of its obligations under this Contract. SOONEST GLOBAL shall be responsible for the extension of its performance security and/or undertake to renew its Performance Security whenever necessary, and without the need for prior notice of instruction from **DEPED**, to ensure that it is in force and effect for the whole duration of the contract delivery period and until a Certificate of Final Acceptance is duly issued. Performance Security shall not contain any deletion, crossing-out, expunction, or any form of correction. Otherwise, **DEPED** may reject such security if any such intercalation, superimposition, or alteration affects any material information, or feature of the document.
- 4. The services referred to in this Contract shall be rendered by **SOONEST** GLOBAL at the designated Recipient Schools within sixty (60) calendar days upon receipt of the Notice to Proceed. SOONEST GLOBAL shall ensure that the required services will be rendered in accordance with the Schedule of Requirements, which is hereto attached as Annex "B" and made an integral part hereof.

Violation of this provision, based on documents and reports submitted and validated by the authorized receiving personnel may be a cause for the termination of the Contract and shall be subject to liquidated damages pursuant to Item 9 of this Contract.

5. The services to be rendered must conform to and comply with the standards mentioned in Section VI. Schedule of Requirements of the EST GLOBAL's Witness

Bidding Documents, and must be in accordance with the Terms of Reference as approved by the Bids and Awards Committee, or as amended by subsequently issued Bid Bulletin, if any, based on SOONEST GLOBAL's submission, and reflected in the post-qualification report, which is hereto attached as Annex "C" and made an integral part hereof.

- In case SOONEST GLOBAL encounters condition(s) impeding timely 6. performance of the required services, SOONEST GLOBAL shall promptly notify **DEPED** in writing within five (5) calendar days from notice of such condition(s). Any request for work suspension and/or contract period extension shall be promptly done in writing as soon as circumstances for such request have become apparent. SOONEST GLOBAL must provide sufficient proof to support any request for work suspension and/or contract period extension.
- The Contract Price shall be paid to **SOONEST GLOBAL** in accordance with 7. the following disbursement procedures:
 - **SOONEST GLOBAL** may submit a request for payment based on the a. following:
 - Value of actual services rendered based on the schedule of delivery and other relevant terms and conditions of the Contract; and
 - Certification by **SOONEST GLOBAL**, duly signed and dated by the authorized representative of **DEPED** indicating that the services have been rendered in accordance with the Contract.

Other documents in support of a request for payment may be required by **DEPED** pursuant to existing disbursement, accounting, and auditing rules and procedures.

- Payment shall be made to SOONEST GLOBAL within 60 days from b. submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by **DEPED** in the following manner:
 - For progress payment, a minimum of 25% of the Contract Price shall be paid to SOONEST GLOBAL upon complete performance of at least 25% of the delivery and acceptance to the recipient schools.

SOONEST GLOBAL must furnish a copy of the above-mentioned documents to the End-User (Bureau of Learning Resources-Cebu).

8. Each party in the performance of their respective duties and responsibilities under this Contract and in the implementation thereof shall adhere to Republic Act No. 10173, otherwise known as the "Data Privacy Act of 2012" and its Implementing Rules and Regulations and applicable National Privacy Commission issuances. The processing of any gathered data and information should be in compliance with the confidentiality and privacy requirements under the said law and applicable regulations.

- SOONEST GLOBAL shall be liable for liquidated damages in an amount 9. equal one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion, for every day of delay until such goods are finally rendered and accepted by DEPED. DEPED shall deduct the liquidated damages from any money due or which may become due to SOONEST GLOBAL, or collect from any of the securities posted by SOONEST GLOBAL, whichever is convenient to **DEPED**. Once the accumulated amount of liquidated damages reaches 10% of the Contract Price, DEPED may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.
- The **PARTIES** shall make exert their best efforts to properly resolve any differences or disagreements with respect to any issue that may arise in connection with this Contract. It shall be settled through amicable means, such as but not limited to, mutual consultation and negotiation.

However, in the event that the **PARTIES** fail to settle the dispute amicably, and before any Party may proceed to litigate in court, the Parties shall first resort to an Early Neutral Evaluation in accordance with the Rules on Alternative Dispute Resolution (ADR). Under Republic Act No. 9285 or the Alternative Dispute Resolutions Act of 2004, an Early Neutral Evaluation is defined as ADR process wherein parties and their lawyers are brought together early in pre-trial phase to present summaries of their cases and receive a nonbinding assessment by an experienced, neutral person, with expertise in the subject in the substance of the dispute.

In case of failure to settle differences, the dispute shall be referred to arbitration administered by three (3) accredited arbitrators to be appointed by both Parties in accordance with the Rules on ADR under RA No. 9285 and other relevant rules, regulations, and issuances.

In case of failure to settle differences, the PARTIES shall not be precluded from submitting dispute to the appropriate courts in the Philippines. Any cause of action for the enforcement of this Contract or any provision hereto shall be instituted only in the courts of competent jurisdiction, specifically in the Pasig City to the exclusion of other venues.
