



**PROJECT:** Printing and Delivery of Fifty (50) Alternative Learning System (ALS) JHS Modules (Rebid of Lot Nos. 1 & 3)

**CONTRACT**

**THIS CONTRACT** made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2023 by and between the **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, represented herein by its Undersecretary and Chief of Staff, **ATTY. MICHAEL WESLEY T. POA**, as per Department Order (DO) No. 001, s. 2023, dated 09 January 2023, and Office Order OO-OSEC-2023-267, dated 17 October 2023 (hereinafter referred to as "**DEPED**"); and **VECO PAPER CORPORATION**, represented herein by its President and Chief Executive Officer, **VICTOR T. LIM**, duly authorized by a Board Resolution, with office address at Concepcion St., Brgy. Buli, Muntinlupa City (hereinafter referred to as "**VECO**").

**DEPED** and **VECO** are collectively called **PARTIES**.

**WHEREAS, DEPED** invited bids for the Printing and Delivery of Fifty (50) Alternative Learning System (ALS) JHS Modules (Rebid of Lot Nos. 1 & 3) consisting of two (2) lots, and received bids from the prospective bidders for Lot No. 3; **DEPED** opened, read, and evaluated the bid and declared **VECO** as having the Lowest Calculated Bid for Lot No. 3; after evaluation, **DEPED** post-qualified and declared the bid of **VECO** as the Lowest Calculated Responsive Bid for Lot No. 3 in the sum of **PHILIPPINE PESOS THIRTY-SIX MILLION, THREE HUNDRED NINETY-FOUR THOUSAND, TWO HUNDRED FORTY-THREE AND 90/100 (PhP36,394,243.90) ONLY**, (hereinafter called the "Contract Price"), detailed as follows:

**NOW THIS CONTRACT WITNESSETH AS FOLLOWS:**

1. In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Contract, *viz*:
  - a. Resolution to Award No. **2023-BAE3(001)-BIV-CB-019a** dated 27 December 2023;
  - b. Philippine Bidding Documents;
    - i. General and Special Conditions of the Contract;

- ii. Schedule of Requirements; and
- iii. Technical Specifications;
- iv. Bid Bulletins No. 1 dated 3 December 2023;

- c. **VECO**'s bid, including the eligibility requirements, technical and financial proposals, and all other documents or statements submitted;
- d. Performance Security;
- e. Notice of Award (NOA) of Contract and **VECO**'s conforme thereto; and
- f. Other contract documents required by existing laws and/or DepEd in the Bidding Documents. **VECO** agrees that additional contract documents of information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution such as, but not limited to, Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.

3. **VECO** shall post a Performance Security within 10 calendar days from receipt of the NOA in the form and amount prescribed therein. The Performance Security shall be posted in favor of **DEPED**, and shall be forfeited in the event that it is established that **VECO** is in default of any of its obligations under this Contract. **VECO** shall be responsible for the extension of its performance security and/or undertake to renew its Performance Security whenever necessary, and without the need for prior notice of instruction from **DEPED**, to ensure that it is in force and effect for the whole duration of the Contract and until a Certificate of Final Acceptance is duly issued.

4. The goods referred to in this Contract shall be delivered by **VECO** within **one hundred twenty (120) CALENDAR DAYS** from the date of the receipt of the Authority to Mass Print. **VECO** shall ensure that the goods will be delivered in accordance with the Schedule of Requirements, which is hereto attached as Annex "B" and made an integral part thereof.

Violation of this provision, based on documents and reports submitted and validated by the authorized receiving personnel may be a cause for the termination of the Contract.

5. **DEPED** shall have the right to visit and inspect **VECO**'s premises covered by the Contract at any time or stage of the contract implementation to monitor and assess **VECO**'s capacity to discharge its contractual obligations.

In accordance with Department Order (DO) No. 41 s. 2021, pre - delivery shall be conducted by the **DepED** through its duly designated Inspectorate Team.

Pre - delivery and Pre - implementation Conference shall be conducted prior to the inspection of goods by the designated **DepEd** Inspectorate Team, as may be necessary or applicable.

6. **DEPED** shall have the right to inspect and test or cause the testing of the goods covered by the Contract, at any time or stage of contract implementation. Prior to and for purposes of inspection, **VECO** shall ensure convenient access to the goods for inspection. **VECO** shall assign personnel to undertake the handling, unpacking, assembly,

commissioning, disassembly, repacking, resealing, and sorting of the goods prior to, during, and after inspection.

7. The goods shall be inspected by the designated Inspectorate Team prior to delivery in accordance with the provisions of the Special Conditions of the Contract, the Schedule of Requirements, or otherwise indicated in other parts of the Bidding Documents. **VECO** shall coordinate with **DEPED**, through the Procurement Management Service-Contract Management Division (ProcMS-CMD), on the conduct of inspection of goods. Any request for inspection shall be done in writing and contain the following information:
- Project Title and Contract Number;
  - Specific goods for inspection;
  - Quantity of goods for inspection;
  - Venue/Address of inspection site; and
  - Proposed schedule of inspection which must be at least 10 calendar days from the submission of the written request.

The request for inspection must be submitted to **DEPED** through ProcMS-CMD or by email at [procms.cmd@deped.gov.ph](mailto:procms.cmd@deped.gov.ph).

8. The goods must conform to and comply with the standards mentioned in Section VI. Schedule of Requirements of the Bidding Documents, and must be in accordance with the final technical specifications as approved by the Bids and Awards Committee, or as amended by subsequently issued Bid Bulletin, if any, based on the samples submitted by **VECO**, and reflected in the post-qualification report, which is hereto attached as Annex "C" and made an integral part hereof.
9. Goods with defects or non-compliant with the required technical specifications upon delivery shall be rejected, orally or in writing, by **DEPED** and replaced by **VECO** in accordance with the warranty provisions in the bidding documents. The replacement of the goods shall be subject to re-inspection.
10. In case **VECO** encounters condition(s) impeding timely delivery of the goods, **VECO** shall promptly notify **DEPED** in writing within five (5) calendar days from notice of such condition(s). Any request for work suspension and/or contract period extension shall be promptly done in writing as soon as circumstances for such request have become apparent. **VECO** must provide sufficient proof to support any request for work suspension and/or contract period extension.

**DEPED** accepts no liability for the damage of goods during transit. Risk and title to the goods will not be deemed to have passed to **DEPED** until its receipt and acceptance at the final destination through its authorized receiving personnel.

11. The Contract Price shall be paid to **VECO** in accordance with the following disbursement procedures:

- i. Supplier's invoice showing goods' description, quantity, unit price, and total amount;
- ii. Duly signed Delivery Receipt/s;
- iii. Duly signed Inspection and Acceptance Report/s (IAR/s), including certification by **VECO**, duly signed and dated by the authorized representative of **DEPED** indicating that the goods have been delivered in accordance with the Contract; and
- iv. Warranty Certificate.

Other documents in support of a request for payment may be required by **DEPED** pursuant to existing disbursement, accounting, and auditing rules and procedures.

- b. Payment shall be made to **VECO** within Sixty (60) days from submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by **DEPED** in the following manner:

- i. For the progress payment, a minimum of twenty-five percent (25%) of the Contract Price shall be paid to **VECO** upon delivery of at least 25% of the goods and acceptance of the same by **DepEd's** authorized representative; and
- ii. One hundred percent (100%) of the Contract Price shall be paid to **VECO** upon completion of printing, packaging, labeling, inspection, delivery of test booklets, test administration, and acceptance of the goods by the duly authorized representative of **DepEd**.

- 12. Payment shall be subject to the "Warranty" provision in the form of either retention money in an amount equivalent to five percent (5%) of the payment or a Special Bank Guarantee in an amount equal to five percent (5%) of the Contract Price required under Section 62 of RA 9184 and its revised IRR.

- a. A three-month comprehensive and onsite warranty for the delivered goods shall reckon from the date of the issuance of the Certificate of Final Acceptance by **DEPED**.
- b. Goods with defect or non-compliant with the required technical specifications upon delivery shall be rejected, orally or in writing, by **DepEd** and replaced by the Supplier in accordance with the warranty provision in the bidding document. The Supplier shall replace all rejected goods within five (5) calendar days from its receipt of the Notice of Rejection from the recipient schools. The replacement goods shall be subject to re-inspection.

In case **VECO** opts for retention money, the amount shall be released at the expiration of the warranty period or the remaining amount in case it has been utilized pursuant to the warranty provision unless, during the remainder of the warranty period, the retention money is substituted with a special bank guarantee.

- 13. Ownership, title, rights, and interest with respect to the contents of the test booklets, including all resources, records, or materials used or obtained in the course of this Contract shall vest exclusively with **DEPED**. **VECO** hereby irrevocably waives any claim thereto. **VECO** shall not, in any

manner or for any purpose, use the contents of the test booklets beyond what is expressly allowed for the purpose of accomplishing the terms under this Contract unless express permission of **DEPED** in writing is obtained.

14. Each party in the performance of their respective duties and responsibilities under this Contract and in the implementation thereof shall adhere to Republic Act (RA) No. 10173, otherwise known as the, "Data Privacy Act of 2012" and its Implementing Rules and Regulations and applicable National Privacy Commission issuances. Any gathered data and information should be protected and inspected during the term and even after the termination of this Contract. The processing of any gathered data and information should be in compliance with the confidentiality and privacy requirements under the said law and applicable regulations.
15. **VECO** shall be liable for liquidated damages in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery, for every day of delay until such goods are finally delivered and accepted by **DEPED**. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **VECO**, or collect from any of the securities or warranties posted by **VECO**, whichever is convenient to **DEPED**. Once the accumulated amount of liquidated damages reaches 10% of the Contract Price, **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.
16. The **PARTIES** shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the **PARTIES** in connection with the implementation of the Contract. Should such dispute not be resolved amicably, it shall be submitted to Early Neutral Evaluation pursuant to Republic Act No. 9285 or the "Alternative Dispute Resolution Act of 2004", and its Implementing Rules and Regulations.
