



**PROJECT:** Supply, Delivery, and Maintenance of DCP E-Classroom Packages 2022  
**CONTRACT NO.:** 2023c-ICTS3(003&016)-BII-CB-023-C067

**CONTRACT**

**THIS CONTRACT** made and entered into this 24th day of November 2023 by and between the **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, represented herein by its Undersecretary and Chief of Staff, **ATTY. MICHAEL WESLEY T. POA**, as per Office Order OO-OSEC-2023-267, dated 17 October 2023 (hereinafter referred to as "**DEPED**"); and **TECHGURU INCORPORATED**, represented herein by its Authorized Representative, **ERICK M. BACUDIO**, with office address at Room 525, 5<sup>th</sup> Floor, Downtown Center Building, 516 Quintin Paredes Street, Binondo, Manila (hereinafter referred to as "**TECHGURU**"), as per Omnibus Sworn Statement dated August 8, 2023 (hereto attached as Annex "A").

**DEPED** and **TECHGURU** are collectively called **PARTIES**.

**WHEREAS, DEPED** invited bids for the DCP e-classroom packages consisting of 16 lots, and received bids from 9 bidders for Lot No. 16; **DEPED** opened, read, and evaluated the bids and declared **TECHGURU** as having the Lowest Calculated Bid for Lot No. 16; after evaluation, **DEPED** post-qualified and declared the bid of **TECHGURU** as the Lowest Calculated Responsive Bid for Lot No. 16 in the sum of **PHILIPPINE PESOS THREE HUNDRED ELEVEN MILLION, SIX HUNDRED SEVENTY-FIVE THOUSAND, THREE HUNDRED EIGHTY-ONE and 32/100 (Php311,675,381.32) ONLY**, (hereinafter called the "Contract Price"), detailed as follows:

**NOW THIS CONTRACT WITNESSETH AS FOLLOWS:**


1. In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Contract, viz:



- c. **TECHGURU's** bid, including the eligibility requirements, technical and financial proposals, and all other documents or statements submitted;
- d. Performance Security;
- e. Notice of Award (NOA) of Contract and **TECHGURU's** conforme thereto; and
- f. Other contract documents required by existing laws and/or DepEd in the Bidding Documents. **TECHGURU** agrees that additional contract documents of information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution such as, but not limited to, Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.

3. **TECHGURU** shall post a Performance Security within 10 calendar days from receipt of the NOA in the form and amount prescribed therein and in compliance with Section 39 of the 2016 revised IRR of RA No. 9184. The Performance Security shall be posted in favor of **DEPED**, and shall be forfeited in the event that it is established that **TECHGURU** is in default of any of its obligations under this Contract. **TECHGURU** shall be responsible for the extension of its performance security and/or undertake to renew its Performance Security whenever necessary, and without the need for prior notice of instruction from **DEPED**, to ensure that it is in force and effect for the whole duration of the Contract and until a Certificate of Final Acceptance is duly issued.


4. The goods referred to in this Contract shall be delivered by **TECHGURU** at **Schools Division Offices** stipulated in the Allocation List (Annex "C" and "E" of the Bidding Documents) within **ONE HUNDRED TWENTY (120) calendar days** from the date of the receipt of the Notice to Proceed (NTP). **TECHGURU** shall ensure that the goods will be delivered in accordance with the Schedule of Requirements, which is hereto attached as Annex "B" and made an integral part hereof.

Violation of this provision, based on documents and reports submitted and validated by the authorized receiving personnel may be a cause for the termination of the Contract.


5. Pre-Delivery and Pre-Implementation Conference shall be conducted prior to the inspection of goods by the designated DepEd Inspectorate Team.

6. **DEPED** shall have the right to visit and inspect **TECHGURU's** premises covered by the Contract at any time or stage of the contract implementation to monitor and assess **TECHGURU's** capacity to discharge its contractual obligations.

7. **DEPED** shall have the right to inspect and test or cause the testing of the goods covered by the Contract, at any time or stage of contract implementation. Prior to and for purposes of inspection, **TECHGURU** shall ensure convenient access to the goods for inspection. **TECHGURU** shall assign personnel to undertake the handling, unpacking, assembly, commissioning, disassembly, repacking, resealing, and sorting of the goods prior to, during, and after inspection.

8. The goods shall be inspected by the designated DepEd Inspectorate Team. **TECHGURU** shall coordinate with **DEPED**, through the Procurement Management Service-Contract Management Division (ProcMS-CMD), on the conduct of the inspection. Any request for inspection shall be done in writing, and submitted in accordance with SCC Clause 4 of the Bidding Documents.
9. The goods must conform to and comply with the standards mentioned in Section VI. Schedule of Requirements of the Bidding Documents, and must be in accordance with the final technical specifications as approved by the Bids and Awards Committee, or as amended by subsequently issued Bid Bulletin, if any, based on the samples submitted by **TECHGURU**, and reflected in the post-qualification report, which is hereto attached as Annex "C" and made an integral part hereof.
10. Goods with defects or non-compliant with the required technical specifications upon delivery shall be rejected, orally or in writing, by **DEPED** and replaced by **TECHGURU** in accordance with the warranty provisions in the bidding documents. The Supplier shall replace all rejected goods within five (5) calendar days from its recipient of the Notice of Rejection from the recipient schools. The replacement of the goods shall be subject to re-inspection.
11. In case **TECHGURU** encounters condition(s) impeding timely delivery of the goods, **TECHGURU** shall promptly notify **DEPED** in writing within five (5) calendar days from notice of such condition(s). Any request for work suspension and/or contract period extension by **TECHGURU** shall be promptly done in writing as soon as circumstances for such request have become apparent. **TECHGURU** must provide sufficient proof to support any request for work suspension and/or contract period extension.  
  
**DEPED** accepts no liability for the damage of goods during transit. Risk and title to the goods will not be deemed to have passed to **DEPED** until its receipt and final acceptance at the final destination through its authorized receiving personnel.
12. The Contract Price shall be paid to **TECHGURU** in accordance with the following disbursement procedures:
  - a. An advance payment not to exceed fifteen percent (15%) of the contract amount shall be allowed and paid within sixty (60) calendar days from signing of the Contract. An irrevocable Letter of Credit or Bank Guarantee of an equivalent amount must be submitted, and shall remain valid until the goods are delivered, and accompanied by a claim for advance payment;
  - b. **TECHGURU** may submit a request for payment based on the following:
    - i. Supplier's invoice showing goods' description, quantity, unit price, and total amount;
    - ii. Duly signed Delivery Receipt/s;
    - iii. Duly signed Inspection and Acceptance Report/s (IAR/s), including certification by **TECHGURU**, duly signed and dated

- by the authorized representative of **DEPED** indicating that the goods have been delivered and properly installed and commissioned in accordance with the Contract; and
- iv. Warranty Certificate.

Other documents in support of a request for payment may be required by **DEPED** pursuant to existing disbursement, accounting, and auditing rules and procedures.


- c. Payment shall be made to **TECHGURU** within 60 days from submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by **DEPED** in the following manner:
  - i. For the initial progress payments, a minimum of 25% of the Contract Price shall be paid to **TECHGURU** upon delivery of at least 25% of the goods and acceptance of the same by the duly authorized DepEd representative;
  - ii. Final payment shall consist of the full and final payment of the unpaid inspected and accepted goods, subject to the submission of the required documents under the Bidding Documents.

13. Payment shall be subject to the "Warranty" provision in the form of either retention money in an amount equivalent to three percent (3%) of the progress payment or a Special Bank Guarantee in an amount equal to three percent (3%) of the Contract Price required under Section 62 of RA 9184 and its revised IRR.


- a. A one-year comprehensive warranty shall be applied to the laptop batteries and optical mouse, and three years for the IT Equipment package including networking peripherals and for operation and maintenance of all licensed software products. The said warranty period shall reckon from the date of issuance of the Certificate of Final Acceptance by the **DEPED** that the delivered Goods have been duly inspected and accepted (i.e. final acceptance).
- b. Replacement and/or repair of the goods may be requested within the aforementioned warranty period. Repair of the goods shall be made within three (3) calendar days upon claim or request therefor. Replacement of the goods, in case the goods cannot be repaired, may be effected within a maximum period of seven (7) calendar days. Replacement must be of the same branding specifications and shall be installed prior to pull-out of the defective or unrepairable unit/s.

In case **TECHGURU** opts for retention money, the amount shall be released at the expiration of the warranty period or the remaining amount in case it has been utilized pursuant to the warranty provision unless, during the remainder of the warranty period, the retention money is substituted with a special bank guarantee.

14. Ownership, title, rights, and interest with respect to the contents of the manuals, including all resources, records, or materials used or obtained in the course of this Contract shall vest exclusively with **DEPED**. **TECHGURU** hereby irrevocably waives any claim thereto. **TECHGURU**





16. **TECHGURU** shall be liable for liquidated damages in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery, for every day of delay until such goods are finally delivered and accepted by **DEPED**. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **TECHGURU**, or collect from any of the securities or warranties posted by **TECHGURU**, whichever is convenient to **DEPED**. Once the accumulated amount of liquidated damages reaches 10% of the Contract Price, **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.






