

#### FRAMEWORK AGREEMENT

#### KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2024 by and between:

The **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, Philippines, represented herein by its Undersecretary, **ATTY. PETER IRVING C. CORVERA**, as per Office Order OO-OSEC-2024-188, dated 9 August 2024 and Office Order OO-OSEC-2024-189, dated 9 August 2024 (hereinafter referred to as "**DEPED**");

-And-

AICEE CATERING FOOD SERVICES a duly registered entity existing under the laws of the Philippines with postal address at Blk 5 Lot 6 Corvette St. Thunderbird Subd. Camarin, Caloocan City, represented herein by its Authorized Representative, ACEREIL V. BASCO, (hereinafter referred to as "AICEE"). DEPED and AICEE are collectively called "PARTIES".

### WITNESSETH, that

WHEREAS, DEPED and AICEE wish to enter in a framework agreement which will enable DEPED, from time to time, to enter into a Call-Off Contract or a series of Call-Off Contracts with AICEE for some or all of the Services of the type describe in the Framework Agreement List.

**WHEREAS**, the terms and conditions of this Agreement shall apply to the comprehensive repair and maintenance services to be provided by **AICEE** under any Call-Off.

WHEREAS, this Agreement is for the option to purchase of goods determined to be necessary and desirable to address and satisfy the needs of **DEPED** but by its nature, use or characteristic, the quantity and/or exact time of need cannot be accurately pre-determined;

WHEREAS, DEPED has the option to purchase the items provided in the Framework Agreement List, attached and made an integral part of this Agreement, on a date and time to be determined in the Call-Off to be issued for such purpose by DEPED; and

WHEREAS, AICEE which passed the eligibility screening conducted by the DEPED, shall maintain and update the eligibility requirements during period of this Agreement and shall honor all obligations under this Framework Agreement.

NOW, THEREFORE, premises considered, the parties hereby agree as follows:

#### Article I GENERAL CONSIDERATIONS

- This Framework Agreement is an option contract. **DEPED** is given the option to either purchase the identified items in the Framework Agreement List or not to purhase at all. The discretion to exercise the option falls solely with **DEPED**. **AICEE** may not require or demand for the latter to purchase the items in the Framework Agreement List.
  - In this Framework Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the conditions of Contract which is attached thereto and made and integral part thereof.
- 3. The following documents shall form part of the Agreement and will have the same force and effect as if expressly set out in the body of this Agreement:
  - a) AICEE's bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - b) Resolution to Award No. \_\_\_\_\_ dated Aug 2,200 and its Annexes;
  - Notice of Execute Framework Agreement (NEFA);
  - d) Schedule of Requirements;
  - e) The Framework Agreement List and Technical Specifications;
  - f) General and Special Conditions of the Contract;
- g) Performance Security or Performance Securing Declaration;

#### Article II DURATION

The term of this Agreement shall be rendered by AICEE at Baguio Teachers Camp within three hundred sixty-five (365) Calendar Days from the date of receipt of the Notice to Proceed (NTP), or the total maximum amount of PHILIPPINES PESOS THIRTY-NINE MILLION, SEVEN HUNDRED, SIXTY THOUSAND and 00/100 (PhP39,760,000.00) specified in the Framework Agreement has been exhausted, whichever comes first, unless sooner revoked by both parties, rescinded by DEPED upon reaching the maximum threshhold on liquidated damages, and/or when the total maximum amount specified in the Framework Agreement List has been exhausted.

#### Article III CONSIDERATION

For the consideration of PHILIPPINE PESOS THIRTY-NINE MILLION, SEVEN HUNDRED, SIXTY THOUSAND and 00/100 (PhP39,760,000.00) ONLY, the DEPED has the option to purchase any or all of the items in the Framework Agreement List through the issuance of Call-off and AICEE commits to deliver the goods and perform the services subject to the conditions of the Call-off.

# Article IV PERFECTION OF PROCUREMENT CONTRACT

The Framework Agreement being an option contract, a procurement contract is perfected only when the **DEPED** exercises the option to procure any item from the Framework Agreement List through the issuance of a Call-off.

## Article V OBLIGATION TO ANSWER A CALL-OFF

Once the **DEPED** issues a Call-off, **AICEE** is bound to deliver the goods or perform the services idnetified at the same time and date specified in the Call-off.
