is made and entered into this CONTRACT 9 2024 by and between the **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, represented herein by its Undersecretary and Chief of Staff, ATTY. MICHAEL WESLEY T. POA, as per Office Order OO-OSEC-2023-267, dated 17 October 2023 (hereinafter referred to as "DEPED"); and SOFTWAREONE PHILIPPINES CORPORATION, represented herein by its General Manager, PAUL PETER S. GARCIA, with office address at 11th Floor 6780 Building Ayala Avenue, San Lorenzo 1223 Makati City Metro Manila (hereinafter referred to as "SOFTWAREONE"), as per Omnibus Sworn Statement dated May 13, 2024 (hereto attached as Annex "A").

DEPED and **SOFTWAREONE** are collectively called **PARTIES**.

WHEREAS, DEPED invited bids for the Procurement of Subscription Licenses for New Media and Multimedia Tools for One Year with contract duration of one (1) year, consisting of one (1) lot, and received bid from lone/number prospective bidder for 1 Lot; **DEPED** opened, read, and evaluated the bids and declared SOFTWAREONE as having the Single/Lowest Calculated Bid; after evaluation, DEPED post-qualified and declared the bid of SOFTWAREONE as the Single/Lowest Calculated Responsive Bid in the sum of PHILIPPINE PESOS TWO HUNDRED NINETY-NINE MILLION, NINE HUNDRED ELEVEN THOUSAND, FORTY and 00/100 (PhP299,911,040.00) only, (hereinafter called the "Contract Price"), detailed as follows:

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

- In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Contract, viz:
 - a. Resolution to Award No. 2024c-ICTS2(006)-BIII-CB-030 dated May 22, 2024

- softwareone bid, including the eligibility requirements, technical and financial proposals, and all other documents or statements submitted;
- d. Performance Security;
- e. Notice of Award (NOA) of Contract and **SOFTWAREONE** conforme thereto; and
- f. Other contract documents required by existing laws and/or DepEd in the Bidding Documents. **SOFTWAREONE** agrees that additional contract documents of information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution such as, but not limited to, Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.
- 3. **SOFTWAREONE** shall post a Performance Security within 10 calendar days from receipt of the NOA in the form and amount prescribed therein. The Performance Security shall be posted in favor of **DEPED**, and shall be forfeited in the event that it is established that **SOFTWAREONE** is in default of any of its obligations under this Contract. **SOFTWAREONE** shall be responsible for the extension of its performance security and/or undertake to renew its Performance Security whenever necessary, and/without the need for prior notice of instruction from **DEPED**, to ensure that it is in force and effect for the whole duration of the Contract and until a Certificate of Final Acceptance is duly issued.
- 4. The services referred to in this Contract shall be rendered prospectively by SOFTWAREONE at the DepEd Central Office within SEVEN (7) CALENDAR DAYS from the date of receipt of the Notice to Proceed (NTP). SOFTWAREONE shall ensure that the goods will be delivered in accordance with Section VI. Schedule of Requirements, which is hereto attached as Annex "B" and made an integral part hereof.

Violation of this provision, based on documents and reports submitted and validated by the authorized receiving personnel is a cause for the termination of the Contract and shall be subject to liquidated damages pursuant to Item 12 of this Contract.

The delivery terms of this Contract shall be Duties Delivered Paid (DDP) in accordance with INCOTERMS.

5. **DEPED** shall have the right to visit and inspect **SOFTWAREONE** premises covered by the Contract at any time or stage of the contract implementation to monitor and assess **SOFTWAREONE** capacity to discharge its contractual obligations.

DEPED shall have the right to inspect and test or cause the testing of the goods covered by the Contract, at any time or stage of contract implementation. Prior to and for purposes of inspection SOFTWAREONE shall ensure convenient access to the goods for inspection. SOFTWAREONE shall assign personnel to undertake the handling, unpacking, assembly, commissioning, disassembly, repacking, resealing, and sorting of the goods prior to, during, and after inspection.

Pre-delivery and Pre-Implementation Conference shall be conducted prior to the conduct of inspection of goods by the designated DEPED Inspectorate Team, as may be necessary or applicable.

7. The services shall be inspected by the designated DepEd Inspectorate Team. **SOFTWAREONE** shall coordinate with **DEPED**, through the Procurement Management Service-Contract Management Division (ProcMS-CMD), on the conduct of inspection or pre-delivery inspection (PDI). Any request for inspection or PDI shall be done in writing, and submitted in accordance with SCC Clause 1 of the Bidding Documents.

Additionally, for the post-delivery **SOFTWAREONE** must provide warranty statement granting technical support services for 12 months either through phone, email, chat, or onsite depending on the support needed.

- 8. The services must conform to and comply with the standards mentioned in Section VII. Technical Specifications of the Bidding Documents, and must be in accordance with the final inspection as approved by the Bids and Awards Committee, or as amended by subsequently issued Bid Bulletin, if any, based on the samples submitted by **SOFTWAREONE**, and reflected in the post-qualification report, which is hereto attached as Annex "C" and made an integral part hereof.
- 9. In case **SOFTWAREONE** encounters condition(s) impeding timely delivery completion of services required, **SOFTWAREONE** shall promptly notify **DEPED** in writing within five (5) calendar days from notice of such condition(s). Any request for work suspension and/or contract period extension shall by **SOFTWAREONE** be promptly done in writing as soon as circumstances for such request have become apparent. **SOFTWAREONE** must provide sufficient proof to support any request for work suspension and/or contract period extension.

DEPED accepts no liability for the damage of goods during transit. Risk and title to the goods will not be deemed to have passed to **DEPED** until its receipt and acceptance at the final destination through its authorized receiving personnel.

- 10. The Contract Price shall be paid to **SOFTWAREONE** in accordance with the following disbursement procedures:
 - a. **SOFTWAREONE** may submit a request for payment based on the following:
 - Actual value of services rendered based on the schedule of delivery and other relevant terms and conditions of the contract; and

ii. Certification by the **SOFTWAREONE**, as approved by the duly authorized DepEd representative, that the required services have been rendered in accordance with the contract.

Other documents in support of a request for payment may be required by **DEPED** pursuant to existing disbursement, accounting, and auditing rules and procedures.

SOFTWAREONE must furnish copy of the above-mentioned documents to the End-User [Information and Communications Technology Service - Solutions Development Division (ICTS - SDD)], DepEd Accounting and the ProcMS-CMD.

- b. Payment shall be made to **SOFTWAREONE** within sixty (60) days after the date of acceptance of the services rendered at the delivery site and upon submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by **DEPED** in the following manner:
 - i. One hundred percent (100%) of the Contract Price shall be paid to **SOFTWAREONE** upon complete performance of the required services, and acceptance by the duly authorized DepEd representative;
- 11. Each party in the performance of their respective duties and responsibilities under this Contract and in the implementation thereof shall adhere to Republic Act No. 10173, otherwise known as the "Data Privacy Act of 2012." and its Implementing Rules and Regulations and applicable National Privacy Commission issuances. Any gathered data and information should be protected and respected during the term and even after the termination of this Contract. The processing of any gathered data and information should be in compliance with the confidentiality and privacy requirements under the said law and applicable regulations.
- 12. **SOFTWAREONE** shall be liable for liquidated damages for the delay in delivery of goods in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery, for every day of delay until such goods are finally delivered and accepted by **DEPED**. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **SOFTWAREONE**, or collect from any of the securities or warranties posted by **SOFTWAREONE** whichever is convenient to **DEPED**. Once the accumulated amount of liquidated damages reaches 10% of the Contract Price, **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.
- 13. **SOFTWAREONE** shall indemnify DepEd against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof.
- 14. The **PARTIES** shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the **PARTIES** in connection with the implementation of the Contract. Should such dispute not be resolved amicably, it shall be submitted to Early

Neutral Evaluation pursuant to Republic Act No. 9285 or the "Alternative Dispute Resolution Act of 2004", and its Implementing Rules and Regulations.

- Allows users to utilize generative AI technology to create images from detailed text descriptions

4. Additional features for the 432,000 licenses with one-time activation

• The software applications must function offline, and only require Internet connectivity for one-time activation.
