CONTRACT

THIS CONTRACT made and entered into this 15th day of Notice 2023 by and between the DEPARTMENT OF EDUCATION, located at DepEd Complex, Meralco Avenue, Pasig City, represented herein by its Undersecretary for Curriculum and Teaching, DR. GINA O. GONONG, as per Department Order No. 001, s. 2023, dated 09 January 2023 and Office Order OO-OSEC-2023-60, dated 14 March 2023 (hereinafter referred to as "DEPED"); and XIMEX DELIVERY EXPRESS, INC., represented herein by its Account Executive, AMITA A. EBRON, with office address at Sto. Domingo Road, Brgy. Mayapa, Calamba City, Laguna (hereinafter referred to as "XIMEX") as per Omnibus Sworn Statement dated June 20, 2023 (hereto attached as Annex "A").

DEPED and **XIMEX** are collectively called **PARTIES**.

WHEREAS, DEPED invited bids for the freight services consisting of three (3) lots, and received bids from four (4) prospective bidders for Lot No. 3; DEPED opened, read, and evaluated the bids of the bidders and declared XIMEX as having the Lowest Calculated Bid for Lot No. 3; after evaluation, DEPED post-qualified and declared the bid of XIMEX as the Lowest Calculated Responsive Bid for Lot No. 3 in the sum of PHILIPPINE PESOS THREE MILLION, SIX HUNDRED FIFTY THOUSAND, FIVE HUNDRED SIXTY and 00/100 (PhP3,650,560.00) ONLY, (hereinafter called the "Contract Price") detailed as follows:

for every day of delay until such goods are finally rendered and accepted by **DEPED**. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **XIMEX**, or collect from any of the securities posted by **XIMEX**, whichever is convenient to **DEPED**. Once the accumulated amount of liquidated damages reaches 10% of the Contract Price, DEPED may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances. The **PARTIES** shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the **PARTIES** in connection with the implementation of the Contract. Should such dispute not be resolved amicably, it shall be submitted to Early Neutral Evaluation pursuant to Republic Act No. 9285 or the "Alternative Dispute Resolution Act of 2004", and its Implementing Rules and Regulations. 10.
