INVITATION TO BID

FOR THE

Supply and Delivery of Gift Certificates for PRAISE CY 2024

1. The **Department of Education (DepEd)**, through the Government of the Philippines (GOP) under 2024 GMS (Current Funds), intends to apply the sum of Philippine Pesos Seven Million, Nine Hundred Eighty Thousand and 00/100 (Php7,980,000.00), being the total Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Gift Certificates for PRAISE CY 2024 detailed as follows:

1 Lot	Gift Certificates (worth P3,500.00 each)	2,280	7,980,000.00

Bids received in excess of the ABC for the project shall be automatically rejected at bid opening.

2. The **DepEd**, through the **Bids and Awards Committee (BAC) III**, now invites bids for the goods/services contemplated in this project. Expected completion of delivery of the goods/services per item is detailed specified in **Section VI. Schedule of Requirements** and **Section VII. Technical Specifications** of this bidding documents.

Prospective bidder should have completed, within a period of **five (5) years** immediately preceding the deadline for submission of bids, Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority's (PSA's) Consumer Price Index (CPI), must be **at least fifty percent (50%)** of the ABC of the lot bid for;

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.



Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 5. For those who are interested to purchase the Bidding Documents, two (2) options are made available, to wit:
 - a. A complete set of Bidding Documents may be acquired by interested Bidders from the DepEd Procurement Management Service – BAC Secretariat Division, Room M-512, 5th Floor, Mabini Building, DepEd Central Office Complex, Meralco Avenue, Pasig City, upon accomplishing a bidder's information sheet and payment of a nonrefundable fee for the Bidding Documents to the DepEd Cashier.

Payment in checks should be made payable to **<u>DECS OSEC Trust</u>**.

b. Interested Bidders may signify their intent to purchase the Bidding Documents through email at <u>depedcentral.bacsecretariat@deped.gov.ph</u> by accomplishing a bidder's information sheet **(Annex "A").** Upon receipt of the bidder's information sheet, the BAC Secretariat Division will send through emailthe details of the DECS OSEC Trust Fund Account for payment. Uponpayment, bidders may send through email the proof of payment before the deadline for submission of bids. Upon receipt of proof of payment, the BAC Secretariat will send the electronic copy of the Bidding Documents.

Amount of Bidding Documents shall be **Philippine Pesos Seven Thousand and 00/100 (PhP7,000.00).**

- The *DepEd* will hold a Pre-Bid Conference for this Project on October 18, 2024, 10:00 A.M. at Bulwagan ng Karunungan, Rizal Building, DepEd Complex, Meralco Ave., Pasig City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before **09:30 A.M.** of October 30, 2024, at Bulwagan ng Karunungan, Rizal Building, DepEd Complex, Meralco Ave., Pasig City.

Late bids shall not be accepted.



- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on October 30, 2024, 10:00 A.M. at Bulwagan ng Karunungan, Rizal Building, DepEd Complex, Meralco Ave., Pasig City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

Only **one (1) representative** per bidder will be allowed to enter inside the venue.

For the purpose of constituting a quorum, both the physical and virtual presence of the BAC members shall be considered pursuant to GPPB Resolution No. 09-2020.

- The DepEd reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
