#### LEASE CONTRACT

THIS CONTRACT is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_\_\_ 2024 by and between the **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, represented herein by its Assistant Secretary for Curriculum and Teaching, **JANIR T. DATUKAN**, as per DepEd Order No. 17, s. 2024, dated 4 December (hereinafter referred to as "**DEPED**"); and **SUKI TRADING CORPORATION**, represented herein by its Authorized Representative, **VICTORIANO B. OCON**, with office address at Fuentes Road, Ibabao, Brgy. Agus, Lapu-Lapu City (hereinafter referred to as "**SUKI TRADING**") as per Omnibus Sworn Statement dated 2 December 2024 (hereto attached as Annex "A").

**DEPED** and **SUKI TRADING** are collectively called **PARTIES**.

WHEREAS, DEPED requested quotations from prospective lessors for the procurement venue for Lease of Real Property to Store Various Learning Tools and Equipment at Various Supplier's Warehouses consisting of three (3) lots, and received a quotation from a sole prospective lessor for Lot No. 3; DEPED evaluated the offer of the prospective lessor and declared SUKI TRADING as having the Single Calculated Quotation for Lot No. 3; after post-qualification, DEPED declared the quotation of SUKI TRADING as the Single Calculated and Responsive Quotation for Lot No. 3 in the sum of PHILIPPINE PESO SIX HUNDRED SEVENTY-SIX THOUSAND AND 00/100 (PhP676,000.00) ONLY, (hereinafter called the "Contract Price") detailed as follows:

In this Contract, words and expressions shall have the same meaning as respectively assigned to them in the Project Reference.

The following documents as required by the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 shall be deemed to form and be read and construed as part of this Contract, viz:

- Resolution to Award Nos. 2024c-BLR4(016)-BV-NPLRPV-065a and a. 2024c-BLR4(017)-BV-NPLRPV-072 dated December 11, 2024;
- Notice of Award of Contract and **SUKI TRADING**'s conforme thereto; b.
- SUKI TRADING's offer, including the eligibility requirements, c. technical and financial proposals, and all other documents or statements submitted;
- Performance Security (if applicable); d.
- Schedule of Requirements; e.
- f. Technical Specifications; and
- Other contract documents required by existing laws and/or **DEPED**. g. SUKI TRADING agrees that additional contract documents of information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution such as, but not limited to, Notice to Proceed and Variation Order, shall form part of the Contract.
- 3. The lease of venue referred to in this Contract shall commence within Fifteen (15) calendar days, subject to SUKI TRADING's receipt of the Notice to Proceed (NTP).
- 4. The lease of venue referred to in this Contract must conform to and comply with the final technical specifications as approved by the Bids and Awards Committee based on the actual offer of SUKI TRADING, and reflected in the post-qualification report, which is hereto attached as Annex "A" and made an integral part hereof.

Any proposal by SUKI TRADING to provide goods, services, and/or equipment of different specifications, in lieu of those approved, shall not be allowed. However, under justifiable circumstances, higher or superior technical specifications may be permitted, subject to the evaluation and favorable recommendation of **DEPED**'s end-user or implementing unit, and the approval of the herein authorized signatory. In any such case, the proposal by SUKI TRADING for substitution shall not result in any additional cost or undue burden to **DEPED**.

- **SUKI TRADING** shall be responsible for the sources of its goods, services, and/or equipment, and shall provide the same in accordance with the schedule and specifications of the award, including incidental and additional services as specified in the Project Reference, if any. Failure on the part of SUKI TRADING to comply with this provision shall be a ground
- conditions of payment to be made to **SUKI T**I agn the Government disbursement procedure within sixty (for after the date of acceptance of Goods at the project Site an acceptance of documents under this contract shall be as follows:

  Advance Payment

  An advance payment not to every amount shall be all signing. The method and conditions of payment to be made to SUKI TRADING through the Government disbursement procedure within sixty (60) days after the date of acceptance of Goods at the project Site and upon

An advance payment not to exceed fifteen percent (15%) of the contract amount shall be allowed and paid within 60 calendar days from the signing of the contract. An irrevocable letter of credit or bank guarantee of an equivalent amount must be submitted and shall remain valid until the an equivalent amount must be submitted and shall remain valid until the goods are delivered, and accompanied by a claim for advance payment.



## **Progress Payment**

Monthly payment for Four (4) months upon submission of billing documents every month. All progress payment shall first be charged against the advance payment until the latter has been fully exhausted.

(NOTE: The Supplier must furnish a copy of the above-mentioned documents to the End-user [(BLR-Cebu)] and the Contract Management Division of the Procurement Management Service, Central Office.)

Other documents in support of a request for payment may be required by **DEPED** pursuant to existing disbursement, accounting, and auditing rules and procedures.

- SUKI TRADING shall be liable for liquidated damages in an amount equal 7. to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion, for every day of delay. DEPED shall deduct the liquidated damages from any money due or which may become due to SUKI TRADING. Once the accumulated amount of the liquidated damages reaches ten percent (10%) of the Contract Price, **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.
- The PARTIES shall make every effort to resolve amicably and by mutual 8. consultation any and all disputes or differences arising between the **PARTIES** in connection with the implementation of the Contract. Should such dispute not be resolved amicably, it shall be submitted to Early Neutral Evaluation pursuant to RA 9285 or the "Alternative Dispute Resolution Act of 2004", and its Implementing Rules and Regulations.
