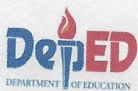




- a.
