Bid opening shall be on <u>August 4, 2023, 11:00 a.m.</u> at <u>BEA</u> <u>Conference Room, 2nd Floor, Bonifacio Building, DepEd</u> <u>Complex, Meralco Ave., Pasig City.</u>, Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

II. Section III. Bid Data Sheet:

• **ITB Clause 20.1, item c,** on pages 23 & 24 of the bidding documents, is hereby deleted:

c. Certificate of Paper Test Result from Forest Products Research and Development Institute (FPRDI) or the Manufacturer of Paper, which must be issued within three (3) months prior to the date of the deadline for the submission and opening of bids for this project. In case the certificate is from the Manufacturer of Paper, the same shall secure a certificate from FPRDI.
